The **Executive Engineer, Sonepur (R&B) Division, Sonepur** on behalf of Governor of Odisha invites **Percentage Rate bids in Double & Single cover system** for the construction of works as detailed in the table, from the class of eligible contractors as mentioned in column-5 (five) registered with the State Governments and Contractors of equivalent Grades /Class Registered with Central Government / MES / Railways for execution of Boundary wall / Roads & Building Works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government has to register under the state PWD in appropriate class of eligibility before signing of the **agreement**.

2. Bids must be accompanied by Earnest Money Deposit / Bid security of the amount specified for the above work **Sl. No. 1 & 2 in the col.06** of above table, pledged in favour of **Executive Engineer, Sonepur (R&B) Division, Sonepur** and will have to be in any one of the forms as specified in the bidding document. Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the state are required to furnish 2% of the amount put to tender as Bid security.
3. The Bid documents will be available in the website www.tendersodisha.gov.in from **5.00 P.M. of 12.11.2018** to **5.00 P.M. of 23.11.2018**.
4. Bids received "on-line" shall be opened **at 12:30 P.M. on 24.11.2018** in the office of the **Executive Engineer, Sonepur (R&B) Division, Sonepur**, Odisha in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
5. The cost of bid documents has to be paid by each bidder in shape of Online mode in favour of the **Executive Engineer, Sonepur (R&B) Division, Sonepur** from any nationalized scheduled bank payable at **Sonepur** for the work **Serial No. 1 & 2 of Rs.10,000/-** towards cost of tender paper.

6. Detailed information as contained in the D.T.C.N. shall have to be strictly adhered to while submitting the tender papers.
7. Engineer Contractor desirous to avail the facility of exemption of E.M.D. is required to submit an affidavit in original to the effect that he has not yet availed the facility for more than three works during the current financial year. The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit failing which the tender will be rejected.
8. The SC/ST Contractor asking for price preference has to upload the affidavit for the same, otherwise the claim for price preference will not be accepted.
9. Other details can be seen in the bid documents.
10. This notice is to be read with all the Clauses / addendum to the "Procedure to participate in online bidding".
11. If any of the intending bidders wish to withdraw from participation in the bid, he/she can freely **withdraw** from the participation before scheduled date and time of closure, failing which action as deemed fit as per relevant codal practice will be taken against him/her.
12. Any corrigendum / Addendum will be displayed in the website www.tendersodisha.gov.in only.
13. If the office happens to be closed on the opening day due to subsequent declaration as holiday in Govt. or local authority the tenders will be opened on the immediate next working day at same time and venue respectively.
14. Conditional tender will be summarily rejected. The department reserves the right to reject any or all bids without assigning any reason thereof.
15. For the work in serial No.2 of tender call notice, the agreement will be drawn after availability of funds.
16. The G.S.T. will be deducted from the bill as fixed by the Government time to time.
17. The bill will be paid as per availability of the fund otherwise the agent will wait for receiving the fund from Government in the proper head.
18. In the bid document of all developmental and infrastructure projects, it will be provided that "Contractor is required to use the material from authorized sources only and he is to certify for the same." Accordingly the concerned department will ensure obtaining such certificates at the time of passing the bill.
19. If the percentage rate of any tender will be same with each other, then the transparent lottery will be done after 3 days of opening of price bid at 11.00 A.M. if the office happens to be closed on the stipulated date the lottery will be done on the next working day at the same time.
