Engineer contractor desirous to avail the facility of exemption of EMD is required to submit an affidavit in original :- Being as Engineer contractor, I have not availed EMD exemption in more than two works in the Financial year 2018-2019. The Engineer contractor has to upload all the pages of license including blank pages for verification of entries made on award of work for exemption of EMD.

The software application has the provision of payment of cost of tender document through payment gateway of authorised bankers by directly debiting the account of the bidders (Designated banks such as SBI/ ICICI / HDFC Bank for all Govt. Departments) The cost of tender paper & EMD is to be deposited online as per works Department Memo No. 17254 dt. 05.12.2017.

However APS need to be deposited only by the successful bidder in shape of Terms deposit (TD) / KVP/ deposit receipt in scheduled bank duly pledged in favour of Executive Engineer RWS&S Division, Jajpur and have to furnish the exact amount of differential cost within 7 days, otherwise the bid shall be cancelled and SD shall be forfeited and proceeding for blacklisting shall be initiated against the bidder.


