Unit wise list of condemned Police vehicles is notified in the Notice Boards of RO Bhubaneswar UPD, Cuttack UPD, CP, Hqrs, Bhubaneswar and OSAP 7<sup>th</sup> Bn., Bhubaneswar for information of the intending persons/vendors. The intending vendors may inspect the vehicles during office hours from 11AM to 5 PM where the vehicles are available and quote the price of the vehicles along with EMD in shape of DD Rs. 1000/- in favour of Addl.DCP, DDO-I, Bhubaneswar for each vehicle in a sealed envelope addressing to DCP, Hqrs, BBSR-CTC, Bhubaneswar. The sealed envelope may be deposited in the box kept in Police Commissionerate, Hqrs, BBSR-CTC, Bhubaneswar by 25.04.18, 5 PM. The sealed envelope will be opened on 26.04.18 in presence of committee constituted for negotiation and participating vender. Before commencement of After negotiation the highest bidders shall deposit 25% of the bidding amount on the spot and the rest 75% of the amount and GST as applicable will be paid within 7 days. After deposit of the full amount and GST, vehicles will be released. If the highest bidder fails to deposit the 75% of the amount within 7 days to release the vehicle, the deposited amount (25% of the negotiated value) will be forfeited. The successful highest bidders shall be liable to pay MV Tax, if any, outstanding against the vehicles and also change the ownership within 7(seven) days. The Authority (Police Commissioner) reserves the right to accept or reject the negotiated price offered by the negotiators without justifying any reason thereof

The vehicles will be delivered as is where is basis and the bidders shall remove the vehicles from the site within 7(seven) days from the issue of release order at their own cost. After delivery of the vehicles, the custody and security of the vehicles shall be the responsibility of the bidders. No further complaint and claim on this account will be entertained. On failure to remove the vehicle within the time as aforesaid, ground rent at the rate of one percent of the negotiated money shall be charged for each day or part of the day till the removal of the vehicle from the site. No complaint will be accepted after finalization of highest bidding amount during negotiation.

The vehicles shall not be delivered to the highest bidder till full payment is made and other formalities are complied with. No tools, equipments or spare parts will be delivered.
