In continuation to the results published vide this Commission's Notice No. 1248/OSSCC dt. 13.06.2025, No. 2471/OSSCC dt. 04.10.2025 & No. 2481/OSSCC dt. 06.10.2025, the Roll Numbers of the candidates who are provisionally screened (additional) and allowed to participate in the document verification for the posts of Livestock Inspector, Forester and Forest Guard under CRE-2023 (II) is published at **Annexure-I**.

The verification of original documents and validation of Biodata of the Candidates under CRE-2023 (II) shall be conducted from **23rd to 25th of October, 2025 at 10:30 onwards in the O/o Odisha Sub-Ordinate Staff Selection Commission**.

The candidates provisionally screened (additionally) for document verification are advised to download the Intimation Letter for the document verification by logging in the web portal of the Commission www.osscc.gov.in with their registered User ID and Password. They are required to attend the document verification process in the O/o Odisha Sub-Ordinate Staff Selection Commission as per the schedule & venue given in their Intimation Letters. If any candidate fails to attend document verification process, his/her candidature shall be rejected and he/she shall not be allowed to participate in the recruitment process any further. It is also made clear that candidature of the candidates for this recruitment is purely provisional and is liable for rejection in the event of inadequacy/deficiency found at any stage. It is further clarified here that, after all the process of verification, candidates will be selected maximum upto 100% as per the advertised vacancies and/or availability of eligible candidates. Those who do not come within 100% vacancies shall not be considered for appointment even if participated in the document verification process and found eligible. **No hardcopy of Intimation Letter will be sent to any candidate by post.**

Further, the candidates are allowed to exercise their options for choice of Post/ District/ Circle/ Division in order of preference by logging into the Commission's website www.osscc.gov.in using their User ID and Password. The Candidates after logging into their account have to Click on **EXERCISE OPTION OF POST/DISTRICT/CIRCLE/DIVISION** appearing under Online Application Management System in '**Applicant Menu**'. This option is available in the website from **20th to 25th of October, 2025**.

If anybody fails to exercise his/her option, he/she will be assigned Post/ District/ Circle/Division as per default preference shown online automatically. No further claim for exercising of option shall be allowed thereafter in any other mode.

Mere participation in the document verification process/ exercise of options does not confer any right upon the candidate for appointment.
