1. Cost of Tender Paper-The bidder shall transfer online the cost of bid document as mentioned in Column-06 of above table as part of its bid through a process as mentioned in the DTCN.
2. **EMD:-**The bidder shall transfer online the cost of EMD as mentioned in Column-05 of above table as part of its bid through a process as mentioned in the DTCN. Otherwise, tender will be treated as non-responsive & viable of rejection.

3. **Additional Performance Security:-**Government has been pleased to abolish the extant provisions of threshold negative bid caps (14.99%) introduced in Appendix-IX, Clause 36 of OPWD Code Volume-II in the procurement of works undertaken by the Govt. of Odisha vide Office Memorandum No. 173 dtd:-03.01.2026 of Works Department.

***Additional Performance Security shall be taken on an incremental basis from the selected bidder for low bid prices in the project works as under:-***

- I. **where the bid price is below 0% but not below 10% of the project cost put to bid**, no additional performance guarantee/security percentage is required.
- II. **where the bid price is below 10% but not below 20% of the project cost put to bid**, the additional performance guarantee/security percentage shall be incremented by 0.1% for every percentage of bid price below 10% of the project cost put to bid starting at 11% with the additional bid performance guarantee being 0.1% and this additional performance guarantee percentage shall be applied on the bid price;
- III. **where the bid price is 20% or more below of the project cost put to bid**, the additional performance guarantee percentage shall be incremented by 0.2% for every percentage of bid price below 20% of the project cost put to bid in addition to 1% of the bid price and this additional performance guarantee percentage shall be applied on the bid price;
- IV. The additional performance guarantee percentage shall be rounded off to the next lower percentage based on whether the decimal point of the percentage of bid price is below 0.5% or next higher percentage based on whether the decimal point of the percentage of bid price is 0.5% or more.
- V. The additional performance security shall be treated as part of the performance security.
- VI. Justification for abnormally low bids shall be scrutinized by the Departmental Technical Committee and recommended to the competent authority of the Administrative Department for the approval of the Additional Performance Security(APS). An abnormally low bid is one in which the Bid price, in combination with other elements of the Bid, appears so low that it raises material concerns as to the capability of the Bidder to perform the contract at the offered price. Procuring Entity may, in such cases, seek written clarifications from the Bidder, including detailed price analyses of its Bid price in relation to scope, schedule, resource mobilization, allocation of risks and responsibilities, and any other requirements of the bid document. If, after evaluating the price analyses, the procuring entity determines that the Bidder has substantially failed to demonstrate its capability to deliver the contract at the offered price, the Procuring Entity may reject the Bid/ Proposal. However, it would not be advisable to fix a normative percentage below the estimated cost, which would automatically be considered as an abnormally low bid.

2. These amendments shall take effect from the date of issue of the O.M.

3. Accordingly, the relevant existing codal/contractual provision stands modified with effect from the date of issue of this O.M.

4. This has been concurred in by the Finance Department vide **File No. FIN-WF1-MISC-0102-2025**

4. Office Memorandum No. 173/W dated 03.01.2026 of the Works Department, Government of Odisha, along with the further clarifications issued vide Office Memorandum No. 632/W dated 09.01.2026, shall be invariably applicable while deciding the tender, as detailed below:

The following clarifications are issued on Works Department Office Memorandum No. 173 dated 03.01.2026

- The phrase “....to abolish the extant provisions of threshold negative bid caps (14.99%) introduced.....” in the first para of the Works Department OM No. 173 dated 03.01.2026 may be read as “.... to abolish the extant provisions of threshold negative bid caps of 15% introduced vide Works Department OM No. 12366/W dt. 08.11.2013 and amended vide Works Department OM No. 1437 dt, 31.01.202.....”
- If more than one bid is quoted (decimal up to two numbers will be taken for all practical purposes), either at the estimated cost put to tender or less than the estimated cost put to tender, the tender accepting Authority will finalize the tender through a transparent lottery system, where all the concerned bidders/their authorized representatives, the concerned SE/EE of the concerned Division and Divisional Accounts Officer (DAO) will remain present.
- If the rate quoted by the SC and ST Category Contractors comes to the rate quoted by the L1 bidder (decimal up to two numbers will be taken for all practical purposes) after availing 10% price preference as per Para 2 of Works Department Resolution No. 27748 dated 11.10.1977, the tender shall be finalized by the tender accepting authority through a transparent lottery system along with other categories of contractors.

As regards the bidding process in which the tender has been floated before the issue of Works Department Office Memorandum No. 173 dt 03.01.2026, the bid shall be finalized as per the earlier provisions in Appendix-IX, Clause 36 of OPWD Code Volume-II.

Additional Performance Security (APS) in shape of NSC/ KVP/ BG/ Post Office Saving Bank Account/ Post Office Time Deposit Account issued by Nationalized Bank pledged in favour of **Superintending Engineer, Sambalpur Irrigation Division, Sambalpur** from any Nationalized/ Scheduled Bank in India counter guaranteed by its local branch at Sambalpur within Seven (7) days of intimation by the Divisional Officer (by e-mail) to the successful bidder otherwise the successful bidder shall be cancelled and the Earnest Money Deposit / Bid Security shall be forfeited. Further proceeding of blacklisting shall be initiated against the bidder as per **Works Department Memorandum No. 14299 dt. 03.10.2017 and Amendment made vide Office Memorandum No. 14459 dt. 20.09.2018**. The time period of such APS deposit must be more than the duration of work.

5. ***Initial Security Deposit @ 2% of contract value shall be furnished by the bidders / bidder in shape of NSC/ KVP/ BG/ Post Office Saving Bank Account/ Post Office Time Deposit Account issued by Nationalized Bank pledged in favour of Superintending Engineer, Sambalpur Irrigation Division, Sambalpur.***
6. Goods and Service Tax (GST) shall be applied as per prevailing rules or as amended from time to time.

9. Any addendum / Corrigendum / Cancellation of above tender will be published in the web-site. [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in), and in the notice board. The system shall generate a mail to those bidders who have already uploaded their tenders and those bidders if they wish, can modify their tenders.
10. Bid documents consisting of qualification, information and eligibility criteria of bidders, plans, specification, and schedule of quantities of the work are available in web-site [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) and the set of terms and conditions of contract and other necessary documents can be seen in the web-site till last date of sale and receipt of tender papers. 11. The bid validity period of the tender is for a period of 90 days from the last date of receipt of the bids. If any bidder/tenderer withdraws his bid/ tender before the said period or makes any modification in the terms and conditions of the bid, the Earnest Money Deposit (EMD) deposited at the time of submission of tender shall stand forfeited.
12. No Engineer of Gazetted rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a contractor till a period of two years after his/her retirement from Government Service without Government permission.
13. Other details including details of Portal Registration, Submission of Bid, Resubmission, and withdrawal of bid can be seen in the bidding document which is available in web-site [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in).
14. The bidders are indispensably required to **submit the Original Copies of Valid License/ PAN CARD/ GSTIN Registration Certificate/ Original Affidavit and authentic proof documents towards purchase of bid documents/ tender papers within 07 (Seven) days from the date of opening of the Bid** otherwise the bid shall be considered as non-responsive, hence liable for rejection. Engineering contractors who are desirous availing the facility of exemption of EMD is required to submit the affidavit in original to the effect that he has not yet availed the facility for 03 (Three) works during the current financial year. Name of the works and authority to whom the tenders have been submitted must be mentioned in affidavit, failing which, the tender will be liable for rejection. However, the original registration license of the Engineering contractor should be produced at the time of opening of tender.
15. If the 1<sup>st</sup> lowest bidder does not turn up for agreement after finalization of tender, then he shall be debarred from participation in bidding for three years and action will be taken to blacklist the contractor.
16. The bidders shall furnish an affidavit at the time of submission of the bid, about the authentication of the tender documents including Registration Certificate, PAN Card, Valid GST clearance certificate and security etc. failing which the bid shall be considered as non-responsive and thus liable for rejection. No adjustment of EMD will be entertained at all under any circumstance. Labour license is to be produced by the successful bidder at the time of agreement.
17. Amendment to Para 3.5.18. of OPWD code Vol-I & rule-29 of Appendix-IX of OPWD code Vol-II "The single tender received in 1<sup>st</sup> call shall be cancelled without opening of the bid & fresh tender will be invited" as per Office Memorandum No. 16 dated. 01.01.2015 of Works Department Govt. of Odisha and as per "Works Department O.M. No. 16, dated. 01.01.2015 implies that single tender received in the first call shall be cancelled without opening of bid and in case when more than one tenderer have been received in the first call and only a single tender is found to be responsive, the same is also liable to be cancelled due to lack of competitive price bidding. (Vide Letter No. 4410 dt. 19.02.2018 of DoWR & Memo No. 4714 dt. 13.02.2018 of the E.I.C., W.R., Bhubaneswar.

18. The bidder should mention his/her **valid E-Mail Address / Phone No.** in the separate sheet for communication regarding the tender. The date of time of the lottery if required will be intimated to the qualified bidders through their **valid E-Mail Id / Contact Number** provided in the tender website.
19. All the existing provision of OPWD Code with amendment from time to time will be applicable is deciding the tender. All correspondence regarding the tender process will be communicated by **valid E-mail address** provided in the tender website. All bidders are requested to check their E-mail from time to time regarding the tender. **No claim whatsoever will be entertained for non-receipt of communication in hard copy.**
20. Agreement shall be drawn only after due verification of ISD & APS of the successful bidder. If any fake documents are detected, criminal proceedings will be initiated against the defaulting bidder and action will be initiated for black listing through the license issuing authority.
21. As Goods and Service Tax has come into force with effect from **01.07.2017**, **GST** as applicable will be paid extra after gross bill amount prepared vide Section-15 and Section-142 (11-C) of Odisha Goods and Service Tax Act-2017.

24. Imposition of penalty on EoT/ Deviation in case of complete work will be as per the DoWR Lr. No. 699/ dtd:-07.01.2021.
25. The On-Line bidder shall digitally sign on all statement, documents certification uploaded by him owning responsibility for their correctness/authenticity as per IT act 2000. If any of the information is found to be false/fabricated/bogus, his/her EMD/BID security shall stand forfeited and his/her registration in the portal shall be blocked and bidder is liable to be blacklisted.
26. **The authority reserves the rights to reject any or all the tenders without assigning any reason thereof.**
27. **The authority will not be held responsible for any technical problem/ failure of network/ Malfunction or Interruption of server during the schedule dates of online bidding.**
